會長霍寶田先生感謝地域總監何偉強先生、區主席鄒燦林先生、區總監李有良先生、各級總監、各區職員及旅團領袖推動本區會務所付出的努力,令北區達致今日的成績。

散會:所有議程經討論後,並無其他事項,會議主席宣佈會議於四時三十五分結束。

### 1. 概要

自 2013 年 9 月起,特區政府以政策檢視需時為由,已 15 次短期延續我們的契約,以使用民新街地段作為區會會址直至 2021 年 12 月 25 日。由於未能預計政府政策,因此我們預算的電器更換工作如更換冷氣等,均未能進行。另外,由於過去兩年多仍未能聘請半職工人,區會的清潔工作需要由區職員及兩個在區會集會旅團的成員及領袖分擔。除達不到清潔的標準外,亦阻礙了區會正常運作及延誤集會時間。最近有一位住在模範邨的居民應聘,期望可以協助解決日常清潔及環境防疫的工作。

由於受到 2019 冠狀病毒病疫情影響,多項活動及訓練幾乎完全停頓。各支部在過去一年只完成了共5項活動,包括小童軍支部的聖誕卡設計比賽、幼童軍支部的繩結章訓練班、童軍支部的專科徽章考驗日、領袖聚會及深資童軍的消防訓練班。

在教育局宣佈停課後,所有領袖及成員訓練以至旅團集會均須暫停。區會在 2021 年 2 月向各旅團做了一項統計,調查在 2020 年內各旅團的面對面集會、網上集會及戶外活動情況。回應率達 8 成,分析結果後,我們發覺除了個別學校旅能維持 10 多次網上集會外,其餘的學校旅,尤其是幼稚園的小童軍團及小學的幼童軍團,網上集會次數幾乎是零。針對未能於網上進行團集會的情況,區會除了繼續鼓勵外,亦著手研究協助方法。

領袖訓練方面,上年度有1位領袖完成木章訓練,將會於第46屆區務委員會就職典 禮進行木章頒發儀式。

港島北區成立至今 59 年,旅團數目變化不大。本區原有 29 個旅 64 團,活躍的共 59 個團。而去年獲得優異旅團嘉許的共有 27 個團,反映出有多於一半旅團可能未有時間申報或訓練、活動、服務及行政工作仍有進步空間。

今年有 4 個旅,分別是城市花園業主委員會、北角官立小學、東華三院李潤田紀念中學及北角協同中學獲總會頒發主辦機構表揚狀,表揚他們在過去 15、20、45 及 50 年持續支持童軍運動。

在人數方面,據各旅團向總會填報的周年人數統計數字顯示,截至 2020 年 12 月 31 日本區共有領袖 232 人,而青少年成員則只有 1031 人,領袖人數比對去年減少了 24 人(下跌了 9.3%)及青少年成員減少了 126 人(下跌了 10.8%)。

### 5. 展望



### Report on the audit of the financial statements

### **Opinion**

We have audited the financial statements of The Scout Association Of Hong Kong Hong Kong Island Northern District Council ("the Association") set out on pages 4 to 10, which comprise the statement of financial position as at 31st March 2021, and the income statement for the year then ended, and notes to the financial statements, including a summary of significant accounting policies.

In our opinion, the financial statements of the Association are prepared, in all material respects, in accordance with the Hong Kong Small and Medium-Sized Entity Financial Reporting Standard ("SME-FRS") issued by the Hong Kong Institute of Certified Public Accountants ("HKICPA") and have been properly prepared in compliance with the Hong Kong Companies Ordinance.

We do not assume responsibility towards or accept liability to any other person for the contents of this report.

# OTES TO THE FINANCIAL STATEMENTS - for the year ended 31st March 2021

### 1. Reporting entity

The Scout Association of Hong Kong is a body corporate with perpetual succession established under Scout Association of Hong Kong Ordinance (Chapter 1005 of the Laws of Hong Kong) for the purpose of furthering and promoting the Scout Movement in the Hong Kong Special Administrative Region ("HKSAR").

The financial statements include the operations of The Scout Association of Hong Kong Hong Kong Island Northern District Council.

The principal activities of the Association are providing enjoyable and attractive scheme of progressive training, based on the Scout Promise and the Scout Law and guided by adult leadership.

### 2. Basis of preparation

These financial statements comply with the SME-FRS and have been prepared under the accrual basis of accounting and on the basis that the District Council is a going concern.

The measurement base adopted is the historical cost convention.

### 3. Significant accounting policies

### 3.1 Revenue recognition

Revenue is recognised when it is probable that the economic benefits will flow to the Association and when the revenue can be measured reliably, on the following bases:

- ♦ Subscription fee and donation income were recognised when received; and
- ♦ Interest income, on an accrual basis using the effective interest method by applying the rate that exactly discounts the estimated future cash receipts through the expected life of the financial instrument or a shorter period, when appropriate, to the net carrying amount of the financial asset.

#### 3.2 Taxation

The Association is exempted from Hong Kong Profits Tax by virtue of Section 88 of the Inland Revenue Ordinance.

### 3.3 Impairment of assets

As assessment is made at the end of each reporting period to determine whether there is any indication of impairment or reversal of previous impairment, including items of property, plant and equipment, intangible assets and long-term investments. In the event that an asset's carrying amount exceeds its recoverable amount, the carrying amount is reduced to recoverable amount and an impairment loss is recognised in the income statement. A previously recognised impairment loss is reversed only if there has been a change in the estimates used to determine the recoverable amount, however not to an amount higher than the carrying amount that would have been determined (net of amortisation or depreciation), had no impairment losses been recognised for the asset in prior years.

# OTES TO THE FINANCIAL STATEMENTS - continued – for the year ended 31st March 2021

### 3. Significant accounting policies - continued

### 3.4 Trade and other payables

Trade and other payables are obligations to pay for goods or services that have been acquired in the ordinary course of business from suppliers. Accounts payable are classified as current liabilities if payment is due within one year or less (or in the normal operating cycle of the business if longer). If not, they are presented as non-current liabilities.

Trade payable are recognised initially at fair value and subsequently measured at amortised cost using the effective interest method.

### 3.5 Related party

- (a) A person, or a close member of that person's family is related to the Association if that person:
  - (i) has control or joint control over the Association;
  - (ii) has significant influence over the Association; or
  - (iii) is a member of the key management personnel of the Association or the Association's parent company.
- (b) An entity is related to the Association if any of the following conditions applies:
  - (i) The entity and the Association are members of the same group (which means that each parent, subsidiary, and fellow subsidiary is related to the others).
  - (ii) One entity is an associate or joint venture of the other entity (or an associate or joint venture of a member of a group of which the other entity is a member).
  - (iii) Both entities are joint ventures of the same third party;
  - (iv) One entity is a joint venture of a third entity and the other entity is an associate of the third entity;
  - (v) The entity is a post-employment benefit plan for the benefit of employees of either the District Council or an entity related to the District Council. If the District Council is itself such a plan, the sponsoring employers are also related to the District Council.
  - (vi) The entity is controlled or jointly controlled by a person identified in (a); or
  - (vii) A person identified in (a)(i) has significant influence over the entity or is a member of the key management personnel of the entity (or of a parent of the entity).

Close members of the family of a person are those family members who may be expected to influence or be influenced by that person in their dealings with the entity.
